The Role of the Victim's Justification of Violence - PubMed • Victims who justify violence may receive less support from third parties, which challenges the typical view that support increases when the victim Surprising or expresses a desire to stay with the perpetrator. **Counterintuitive Findings** • Victim-blaming may not always increase when in IPV Research violence is frequent, as some studies suggest that frequency alone doesn't necessarily lead to more victim-blaming or less willingness to support. • Mixed methods (combining qualitative and quantitative approaches) are crucial to understanding IPV, offering insights that purely quantitative or qualitative methods may miss. Methodological • For example, qualitative approaches to IPV can **Contributions** uncover cultural determinants and personal histories of aggressors that are hard to quantify but critical to understanding the root causes of violence • Race, gender identity, socioeconomic status, and disability intersect with IPV, shaping both the experiences of victims and the responses from third parties. Cultural variations in how IPV is viewed, such as in East Asia versus Western Europe, **Intersectional Factors** highlight the influence of socio-cultural contexts. • The role of gender stereotypes, as reflected in the Brazilian context, where IPV may be culturally normalized or justified by patriarchal views, was emphasized. • Specific risk factors for IPV in marginalised communities, including cultural practices and socioeconomic stressors, were discussed. In Brazil, factors like alcohol use and jealousy were strongly **Risk Factors in** associated with IPV perpetration. **Marginalised Communities** Technology is increasingly used to perpetrate IPV, especially in urban settings, where digital

	harassment and tracking are more common, whereas rural settings tend to see more traditional forms of offline abuse.
IPV in Diverse Relationship Structures	IPV in LGBTQ+ relationships was highlighted as requiring specific attention in training professionals. There's a need for targeted resources in the Global South, where cultural understandings and professional capacity regarding IPV dynamics are often insufficient.
Effective Prevention Strategies	<ul> <li>Cognitive-behavioral therapy and interventions targeting emotional regulation, such as anger management, were identified as effective in reducing IPV among perpetrators.</li> <li>Community-based interventions focusing on bystander support have shown potential in preventing IPV. The willingness of third parties to intervene is crucial, and strategies should be developed to overcome biases or cultural inhibitors against intervention.</li> </ul>
Technology and IPV	The use of technology (e.g., digital tracking, social media harassment) in IPV was discussed, highlighting the need for new intervention strategies that address these modern forms of abuse, especially in urban settings.
